### Model GFR VELO-ECO<sup>H</sup> Pendent & Recessed Pendent (SIN R6043)

#### Features

1. Provides Extended Coverage Ordinary Hazard protection to 400 ft<sup>2</sup> (37.2m<sup>2</sup>) per sprinkler.
2. Very extra large orifice of nominal K =14 (200) permits low pressures.
3. Available in pendent or recessed pendent styles.
4. Recessed pendent version provides 3/4" (19mm) adjustment to flush pendent position.
5. 212°F (100°C) or 165°F (74°C) temperature rating.
6. Available in brass, chrome, black plated and polyester coated finishes.
7. Can be used for all editions of NFPA 13.

#### Description

The Reliable VELO—ECO<sup>H</sup> Extended Coverage Sprinkler has a very extra large orifice with a nominal K=14 (200). It can provide Ordinary Hazard protection to 400 ft<sup>2</sup> (37.2m<sup>2</sup>) at lower pressures than an XLO which has a nominal K=11.2 (160). VELO sprinklers are standard response and are available in a pendent or an attractive recessed pendent type which provides up to 3/4" (19mm) of escutcheon adjustment. Various finishes are available.

Reliable VELO—ECO<sup>H</sup> sprinklers provide protection in Ordinary Hazard Group 1 and 2 Occupancies to 400 ft<sup>2</sup> (37.2 m<sup>2</sup>) per sprinkler when the system is designed to NFPA 13 hydraulic density requirements.

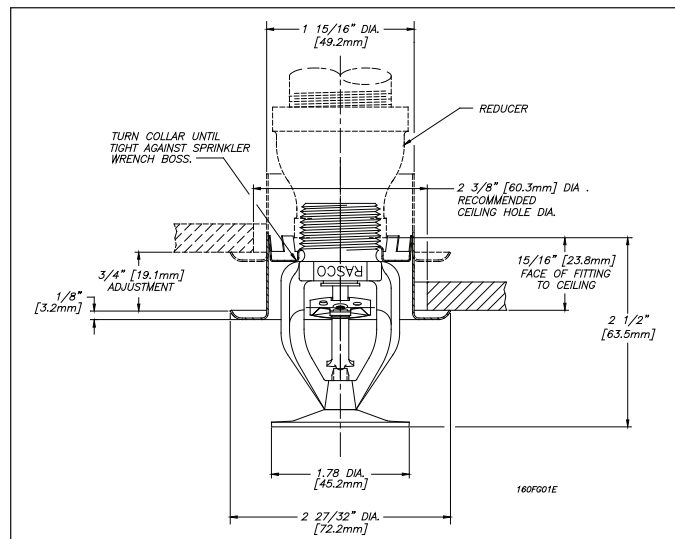
ECO<sup>H</sup> pendent and recessed pendent sprinklers are to be installed according to the design criteria shown in this bulletin. The use of ECO<sup>H</sup> sprinklers can provide lower system installation costs by requiring fewer sprinklers, less piping and reduced labor.

Model GFR VELO sprinklers use a levered fusible alloy solder link.

#### Design Criteria

Reliable Model GFR VELO—ECO<sup>H</sup> sprinklers shall only be used in systems designed and installed in accordance with NFPA 13 and all other local codes and ordinances. The following design criteria also apply:

- Minimum sprinkler spacing is 13 ft. (4.0m).
- Sprinklers have a minimum flow requirement for each spacing as shown in the "Flow Requirements" Table on the reverse side.
- ECO<sup>H</sup> sprinklers are only to be used in systems hydraulically designed per NFPA 13 and for a minimum area of 1500 ft<sup>2</sup> (139m<sup>2</sup>) or 5 sprinklers, whichever is greater.
- Deflector to commodity clearance shall be a minimum of 18" (457mm).
- ECO<sup>H</sup> sprinklers shall be installed in unobstructed constructions as defined in NFPA 13. For open web truss construction web thickness is not to exceed 1" (25mm).
- ECO<sup>H</sup> sprinklers, which are installed above the bottom of a horizontal obstruction, shall have their deflectors located as shown in the "Obstruction Table" on the reverse side.
- Sprinklers can be installed under a sloping ceiling not exceeding 2 inches (50mm) of rise in 1 ft. (0.3m).
- Maximum working pressure is 175 psi (12 bar) at the sprinkler.
